The Directorate of Education has shared information as per notification number DE.23 (08 )/Sch. Br./2021/454 dated 31.08.2021 regarding reopening of schools for Classes IX – XII on voluntary basis to conduct regular classes. Attending offline classes is subject to your consent, following the **COVID APPROPRIATE BEHAVIOUR (CAB) guidelines**. The school will only be running offline classes with live streaming w.e.f. 15.09.2021 (Wednesday) for Classes IX to XII. Students to report in school uniform. **The school hours will be**

It is mandatory for all the students to bring the consent letter (on day one only) from their parent / guardian for attending the offline classes and they should also submit the online consent form which has been sent on the parent email ID as per school records.

**COVID-19 guidelines to be strictly followed.**

**Guidelines for Parent/Guardian:**

1. Students will be allowed to attend the school only with parental consent.
2. Ensure that your ward comes to school wearing a face mask, face shield, carry a hand sanitizer, a pair of disposable gloves and maintains social distance.
3. Clean and sanitize your ward's uniform and other belongings daily.
4. Monitor your ward's health regularly. The school has the authority to send back the student home in case he/she does not comply with the safety measures and social distancing measures or if he/she is found unwell/with temperature above 98.6°F
5. Do not send your ward to the school in case he/she is unwell or if any family member is unwell especially with symptoms related to COVID-19.
6. Respiratory etiquettes to be followed strictly - covering one's mouth and nose while coughing/sneezing with a tissue/handkerchief/flexed elbow and disposing off used tissues properly.
7. Students will not be allowed to share food, water or any other stationary items.
8. Student living in the containment zone should not attend offline classes.
9. The school will not provide transport facility, it will be the sole responsibility of Parent/Guardian to ensure the drop and pick of his/her ward.
10. Routine guest visits during the school hours will be discouraged. However, during emergency, Parent's visit with proper COVID Appropriate Behaviour (CAB) protocol may be permitted.
11. It is suggested that parent/guardian download the AAROGYASETU APP and let his/her ward commute only when the App shows safe and low-risk status.
