Dear Sir,

With reference to the application dated 15.11.1979, I have been directed to convey sanction of the Appropriate Authority for provisional affiliation/recognition to the abovesaid school for All-India Secondary School Examination of the Board w.e.f. 1.5.1980 to 30.4.1982. The recognition has been granted in pursuance of the Gazette Notification No. 80 dated 1.9.1979 issued by the Government of India, Ministry of Education and Social Welfare designating the Central Board of Secondary Education, New Delhi as an Appropriate Authority under Delhi School Education Act, 1979 in respect of schools in the Union Territory of Delhi which may prepare candidates for Board's All-India Secondary School Examination.

The sanction is subject to fulfilment of the following conditions:-

1. The school will follow syllabi and courses as per scheme of studies prescribed by the Board for All-India Sec. School Examination and the changes made therein from time to time.
2. The school will intimate the Board immediately the names of languages and activities of S.U.P.W. and other subjects being followed by it under All-India Scheme.
3. A Reserve Fund be created immediately as per rules.
4. A suitable qualified Principal in terms of the minimum qualifications prescribed by the Board be appointed immediately under intimation to this office.
5. Affidavits duly attested by a 1st Class magistrate, in respect of Mrs. Saroj Chamoli, Mrs. S. Nagarajan, Mrs. Varsha Shukla and Mrs. Sushma Singh regarding change of their names after their marriage be furnished to this office.
6. Original B.Ed. Degrees in respect of Shri S.C. Nagpal, Sh. Navin Sharma and Miss Punam Bakshi, original degrees/diplomas/certificates in respect of Miss R.B. Saraswathi, Mr. Rama Kant, and Sh. V.K. Pandey, original marks statement of B.A. in respect of Miss Punam Bakshi be produced for verification which could not be produced at the time of inspection.

7. The school should obtain land for the school and construct its own building.
8. The Managing Committee of the school be reconstituted as per requirements of the Delhi Education Act.
9. The school should spend Rs.5,000/-for the purchase of library books.
10. The school should provide equipment worth Rs.5,000/- in the Science laboratories.
11. The school shall appoint only qualified and eligible staff.
12. Service agreement shall be executed. Services of any employee of the school shall not be terminated without the prior approval of the Competent Authority.
13. Service conditions, Pay & Allowances and other benefits to employees of the school shall in no way be less than corresponding employees working in Govt. Schools of the Union Territory of Delhi.
14. The school and its records shall be open for inspection by an official of the Board at any time and the school shall furnish informations as may be asked for by the Board from time to time.
15. The school shall not run on profit basis nor for accruing any advantage ^{to} ~~of~~ ^{to} group of persons.
16. The school premises or the property shall not be used for commercial or residential purposes (except where staff quarters are there) or for communal, political or non-educational activities of any kind whatsoever.
17. The rate of tuition and other fees shall not be changed without the prior permission of the competent authority.
18. The admission to the school shall be open to all without discrimination on the ground of religion caste & race, place of birth or any of them.
19. No unrecognised classes shall be run within the premises of the school.
20. The school will help the board in the smooth conduct of the examinations by placing the necessary accommodation i.e; Halls/rooms available in the school premises and furniture at its disposal for holding its examination free of charge if required to do so.
21. The school will spare sufficient teachers for invigilation purposes at the examinations of the board as may be required by the Board.
