Sir,

With reference to the correspondence resting with this office on the subject noted above, the Director of Education is pleased to accord the recognition of the school subject to the fulfilment of the following conditions :

1. The management shall put in serious efforts to get the suitable plot for school.
2. That Management should start the construction of the school building by 30.4.1981.
3. The Management shall ensure that it has adequate funds to meet its financial responsibilities for regular payment of salary and allowances to its employees.
4. The Management shall not run for profit to any individual, group or association of individuals or any other persons.
5. Admission to the school shall be open to all without any discrimination based on religion, caste, race, place of birth or any of them.
6. The Managing Committee observes the provisions of the Act and the rules made thereunder.
7. The arrangement in the building or other structure and the furnishing thereof meet adequately for the requirement of health and hygiene.
8. The school building or other structures or the grounds are not used during the day or night for commercial or residential purposes (except for the purpose of residence of any employee of the school) or for communal, political or non educational activity of any kind whatsoever.
9. Sanitary arrangements at the school are adequate and are kept in good order and a certificate from the Health Officer of the local authority having jurisdiction over the area in which the school is located as to the health and sanitary conditions of the school and its surroundings has been furnished and will also be furnished as and when required by the appropriate authority.



10. Arrangements are made for the supply of good drinking water to the students and suitable facilities are provided to enable them to take refreshments, lunch or the like.
11. No teacher or student of the school is compelled to attend a class in which religious instruction is given or take part in any religious activity.
12. Facilities are provided for teaching of languages in accordance with the three language formula, as adopted by the Central Govt.
13. The school will be open to inspection by any of the officers of this Directorate.
14. The school furnishes such reports and information as may be required by the Director from time to time and complies with such instructions of the appropriate authority.
15. All records of the school will be open to inspection by any officer authorised by the Director or the appropriate authority at any time, and the school furnishes such information as may be necessary to enable the Central Govt. or the Administrator to discharge its or his obligations to Parliament or to the Metropolitan Council of Delhi as the case may be.
16. Adequate library facilities, in a separate room shall be provided with a stock of books specified by the Director or by the Officiating Board.
17. Well equipped science laboratory shall be provided for teaching science.
18. Special arrangements shall be made for providing as many co-curricular activities as may be possible so as to give to every student any opportunity of participating in one or more from the activities like, debates, recitation or elocution, dramatics, music (including folk songs), dancing (including folk dances), hobbies of different types, model Parliament, House system, prefectorial system, class competitions, junior wing of the N.C.C., Scouting & Guiding, Activities provided for social services, and any other co-curricular activities.
19. All facilities prescribed under rule 57, shall be made available to the institution.
20. Service contract between the management and the employees should be executed immediately.

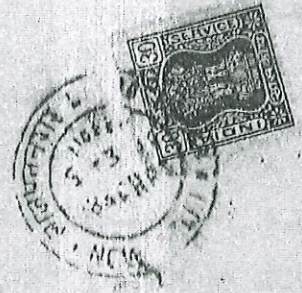








9. That the school shall dispense with the services of unqualified and overaged staff, if any, immediately.
10. That the scheme of management shall be got approved from the Department immediately.
11. That the service contract between the management and the employees shall be executed immediately.
12. That all the facilities prescribed under Rules 50 and 51 of the DSER, 1973 shall be made available to the students.
13. That the arrangements for good drinking water shall be made available to all the students as well as to the teachers and sanitary facilities shall also be provided to the students adequately. Health Certificate may be obtained from the local body within a month.
14. That the management of the school shall create a reserve fund of Rs.15,000/- (Rupees Fifteen Thousand only) in addition to the previous reserve funds, which were created at the time of middle and secondary recognition/upgradation.
15. That the violation of any instructions/orders/conditions/rules and regulations of the department shall lead to the withdrawal of recognition of the school.
16. That the school shall replace the temporary structure by pucca building as per the specifications of the Department within a period of two years on the land of the society for the purpose of the school.
17. That the management of the school shall immediately apply for affiliation of the school with Secretary, CBSE through the Education Officer concerned.
18. That a report about the fulfilment of the above conditions giving the extent to which each condition is fulfilled, shall be sent to the Education Officer every six month.
19. That the school society shall make further correspondence at the present address.
20. That the school society shall be liable to refund the amount of Rs.2,30,750 to the students after leaving the school.

Sub:- Upgradation of school from Secondary to Sr. Secondary level  
(without aid) with effect from academic session 1984-85.

Sir,

With reference to your application on the subject cited above, approval for the upgradation of the existing secondary school to Sr. Secondary level is granted with effect from 1984-85 session subject to the fulfilment of the following terms and conditions:-

1. That the school shall abide by the provisions of Delhi School Education Act & Rules framed thereunder as well as the instructions issued from time to time.
2. That the school shall admit students without any discrimination of caste and creed.
3. That the school shall appoint full time qualified and eligible staff for all the classes of the school as per the present norms of the Department. Additional staff shall be provided for Sr. Sec. classes immediately and head of the school may be promoted as per the norms of the Department.
4. That a proper library shall be established and facilities for reading room shall also be made available for students as well as Teachers. Books as per the ratio of 10 books per student shall be provided.
5. That adequate sports material worth Rs.8,000/- shall be purchased and made available to the students immediately.
6. That the school shall strictly abide by the provisions of Sec.10(1) of the Delhi School Education Act & Rules, 1973.
7. That the enrolment of section shall not exceed the number of students calculated @ 12 sq.ft. per student for the available floor area of the classroom and the school shall provide adequate and sufficient accommodation as per the norms of the Directorate of Education, Delhi in each class. Number of sections should not exceed the number of existing classrooms of proper size in the school.
8. That the school shall not run any unrecognised classes or any other activities within the school premises and all the recognised classes shall be run at one place at the above address only. Nursery class be removed from the premises of the school, if any.
